use cookies on their website [www.profidecon.de](http://www.profidecon.de) (hereinafter referred to as the "**Website**"), as joint Controllers (hereinafter referred to as the "**Controller**").

Cookies are small text files that a web browser can store on your device when you visit a website. They are used to ensure the functionality of certain elements of the website or, for example, to enable the website to better record traffic on the website.

## 2. TYPES OF COOKIES ON THE WEBSITE

The Controller may use the following types of cookies on the Controller's website:

- **functional (necessary) cookies**, which serve to ensure the basic functionality of some elements and functions of the website and, if the Controller does not use them, some functions of the website would not be displayed to you correctly.
- **analytics cookies, which are** used to measure website traffic and visitor activity on the website,
- **marketing and preference cookies**, which are used to detect your preferences in the online environment and to personalise advertisements in web browsers and on social networks.

Under current legislation, the Controller is entitled to store functional (necessary) types of cookies on your device without your consent. **You can disable the use of functional cookies via your browser settings.** In this case, however, some functions of the website will not be displayed correctly.

Other types of cookies (analytical, preference and marketing cookies) **are stored by the Controller on your device only if you grant your consent to their use via the cookie bar (cookie banner) located at the bottom of the website. If you do not give the Controller your consent to the storage of analytical and marketing cookies, the Controller will only store functional (necessary) types of cookies on your device.**

You can revoke or change your consent to the storage of cookies on your device by using the cookie bar at the bottom of the website.

## 3. VALIDITY

This Website Cookie Policy is valid and effective from 2024.1.12. The Controller is entitled to update and change this Cookie Policy. In the event of changes to this policy, the Controller will notify you of the changes in advance.
